CREDIT TERMS & AGREEMENT

1 | Sold in case units:

Minimum order is one case. 1-case is six units. Case can be a mix of products within the same product family. (I.e., combine a mix of six of the Artisan Frauxmage Products of Bleu, Brie, Chevre & Feta to make up a case.)

2 | Wholesale Pricing Tiers.

- . **Tier-1** 25% discount – Purchases up to \$200.00
- . **Tier-2** 30% discount - \$201.00 - \$500.00
- . **Tier-3** 35% discount - \$501.00 - \$800.00
- . **Tier-4** 40% discount - \$801.00 +

3 | Ordering:

- . Order Cut-Off is Wednesday at 8PM.
- . Orders placed on time will be delivered Thursday of each week (weather permitting).

4 | Distribution/Shipping:

Nourish LLC has elected to sell B2B. Our products are not available using traditional grocery distribution companies. For deliveries out of town, but within Vermont we will deliver direct or use Green Mountain Messengers. Orders under \$500.00 will incur delivery charges.

5 | Invoices

- . Invoices are due on delivery unless prior credit terms have been approved. Invoices on credit terms must be paid within 30 days of the date issued.
- . A late payment surcharge of 2% / month will be levied on overdue accounts.
- . A discount of 2% will be applied to invoices paid within 3-days of issue.

6 | Damage Claims

- . Any damage claims regarding a delivery must be made within 3-days of the delivery date.
